

SOFTWARE LICENSE AGREEMENT PROVISIONS

1. This is an agreement between NEBENS LLC, the Licensor, and Licensee, who is being licensed to use the NEBENS MIMObit Simulation Software, the Software.
2. The Software is solely owned by NEBENS LLC and it is protected by copyright and associated international treaty laws. NEBENS, MIMObit, RadMap, PropStats, OrientStats are registered trademarks of NEBENS, LLC.
3. Licensee acknowledges that this is only a limited nonexclusive license and is provided "as is".. The Software has been built using some GNU tools and Matlab, a trademark of Mathworks. GNU software is covered by the GNU General Public License (<http://www.gnu.org/licenses/licenses.html#GPL>) and can be downloaded directly from the GNU web site www.gnu.org. Apart from the GNU tools, Licensor is and remains an authorized distributor and/or the owner of all titles, rights, and interests in the Software. Mimobit also uses a routine for reading touchstone files copyrighted (c) by Tudor Dima in 2009. This latter software reading touchstone files is provided by the copyright holders and contributors "as is" and any express or implied warranties, including, but not limited to, the implied warranties of merchantability and fitness for a particular purpose are disclaimed.
